ORDER

On April 6, 2018, Cypress Creek Renewables, LLC, filed a complaint against DTE Electric Company. On August 16, 2019, the parties submitted a joint stipulation for voluntary dismissal without prejudice.

THEREFORE, IT IS ORDERED that the complaint of Cypress Creek Renewables, LLC, against DTE Electric Company is dismissed without prejudice.

The Commission reserves jurisdiction and may issue further orders as necessary.

Any party desiring to appeal this order must do so in the appropriate court within 30 days after issuance and notice of this order, pursuant to MCL 462.26. To comply with the Michigan Rules of Court's requirement to notify the Commission of an appeal, appellants shall send required notices to both the Commission's Executive Secretary and to the Commission's Legal Counsel. 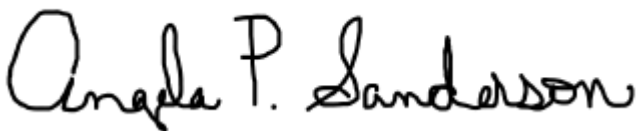
