ORDER

On September 23, 2019, the parties to this proceeding filed a joint stipulation requesting that the Commission issue an order dismissing this matter consistent with the settlement agreement filed in Case No. U-20615 and approved by the Commission on September 11, 2019, without Commission-ordered costs, fines, attorney fees, or other sanctions, and without prejudice in the event that the settlement agreement is voided or withdrawn as a result of any appeal.

The Commission has reviewed the joint stipulation and finds that the request to dismiss the complaint without prejudice is reasonable and consistent with the settlement agreement approved on September 11, 2019, in Case No. U-20615.

THEREFORE, IT IS ORDERED that the complaint of Argentine Solar, LLC; Burr Oak Solar, LLC; Burton Solar, LLC; Davison Solar, LLC; Dixie Highway Solar, LLC; Fife Solar, LLC; Fifteen Mile Road Solar, LLC; Fruitport Solar, LLC; Ionia Solar, LLC; Irish Road Solar, LLC; King Road Solar, LLC; Knox Solar, LLC; Long Road Solar, LLC; Onion Creek Solar, LLC; Pewamo Solar, LLC; Vermontville Solar, LLC; and White Star Solar, LLC, against Consumers Energy Company is dismissed without prejudice in accordance with the joint stipulation.

The Commission reserves jurisdiction and may issue further orders as necessary.

Any party desiring to appeal this order must do so in the appropriate court within 30 days after issuance and notice of this order, pursuant to MCL 462.26. To comply with the Michigan Rules of Court's requirement to notify the Commission of an appeal, appellants shall send required notices to both the Commission's Executive Secretary and to the Commission's Legal Counsel.

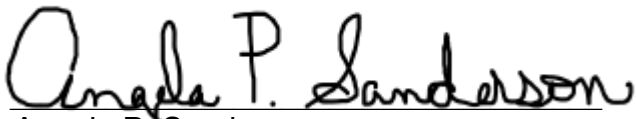
