### **ORDER**

Public Act 295 of 2008, MCL 460.1001 *et seq.*, as amended by Public Act 342 of 2016, MCL 460.1001 *et seq.*, requires all providers of electric service in this state to make certain renewable energy filings with the Commission. MCL 460.1049(1) requires the Commission to conduct an annual renewable energy cost reconciliation for all rate-regulated electric providers. This order establishes docket numbers and filing dates for these cases. Member-regulated cooperatives, municipally-owned utilities, and alternative electric suppliers are not subject to a renewable energy plan reconciliation requirement.

Exhibit A provides filing dates and case numbers for the 2019 renewable energy cost reconciliation cases for the year ended December 31, 2019.

THEREFORE, IT IS ORDERED that each of the above-captioned electric providers shall file its renewable energy cost reconciliation application in the assigned docket number by the dates listed on Exhibit A.

The Commission reserves jurisdiction and may issue further orders as necessary.

Any party desiring to appeal this order must do so in the appropriate court within 30 days after issuance and notice of this order, pursuant to MCL 462.26. To comply with the Michigan Rules of Court's requirement to notify the Commission of an appeal, appellants shall send required notices to both the Commission's Executive Secretary and to the Commission's Legal Counsel. 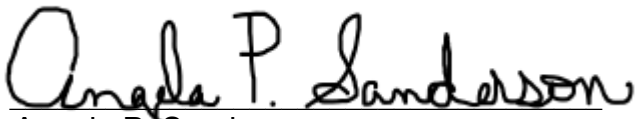
