**ORDER**

On June 8, 2020, pursuant to Mich Admin Code, R 792.10437(1), the Utility Workers Union of America, Local 223 (Local 223), filed a petition for reconsideration or rehearing of the Commission's decision regarding DTE Electric Company's reporting requirements related to its aging workforce as set forth in the May 8, 2020 order in the instant case. On June 12, 2020, Local 223 filed a request to withdraw its petition for reconsideration or rehearing. On June 16, 2020, Local 223 filed an erratum to its June 12 filing to correct the date of its original petition for rehearing, as set forth in its withdrawal of the petition.

The Commission has reviewed Local 223's petition for reconsideration or rehearing and its subsequent withdrawal of the petition and finds that the withdrawal should be approved and the petition dismissed without prejudice.

THEREFORE, IT IS ORDERED that the petition for reconsideration or rehearing filed by the Utility Workers Union of America, Local 223, is dismissed without prejudice.

The Commission reserves jurisdiction and may issue further orders as necessary.

Any party desiring to appeal this order must do so in the appropriate court within 30 days after issuance and notice of this order, under MCL 462.26. To comply with the Michigan Rules of Court's requirement to notify the Commission of an appeal, appellants shall send required notices to both the Commission's Executive Secretary and to the Commission's Legal Counsel.

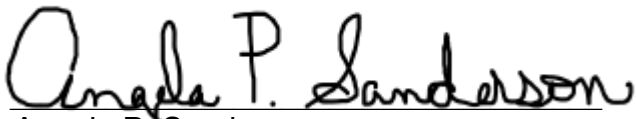
