ORDER

On April 24, 2001, CynergyComm.net, Inc., f/k/a UTMI.net, f/k/a United Telecom, Inc., (CynergyComm) filed an application in this docket, pursuant to the Michigan Telecommunications Act, MCL 484.2101 *et seq.*, for a license to provide basic local exchange service in all exchanges currently served by Ameritech Michigan, Verizon North Inc., Contel of the South, Inc., d/b/a Verizon North Systems, CenturyTel of Michigan, Inc., CenturyTel of Northern Michigan, Inc., CenturyTel Midwest, Inc., and CenturyTel of the Upper Peninsula, Inc. On August 16, 2001, CynergyComm was granted a permanent license.

On April 9, 2021, CynergyComm informed the Commission of its intent to voluntarily surrender the license. CynergyComm asserts that no customer's local exchange service will be

impacted by this cancellation, and that CynergyComm has no remaining customers receiving local exchange service under this license, which was also noticed to the Commission in Case No. U-20860.¹ CynergyComm further states that after extensive market analysis, it has determined that its strategic business plans do not include continued provision of telecommunications services.

The Commission finds that CynergyComm's request to voluntarily surrender its license to provide basic local exchange service should be granted because the company has no customers in the state of Michigan and does not intend to provide further service in the state.

THEREFORE, IT IS ORDERED that:

A. The license of CynergyComm.net, Inc., f/k/a UTMI.net, f/k/a United Telecom, Inc., to provide basic local exchange service is voluntarily surrendered.

B. CynergyComm.net, Inc., f/k/a UTMI.net, f/k/a United Telecom, Inc., shall surrender to the North American Numbering Plan Administrator any numbers that have been assigned to it for the purpose of providing basic local exchange service in Michigan under the license.

¹ CynergyComm's notice to discontinue the provision of wireline services in Michigan was processed in Case No. U-20860.

The Commission reserves jurisdiction and may issue further orders as necessary.

Any party desiring to appeal this order must do so by the filing of a claim of appeal in the Michigan Court of Appeals within 30 days of the issuance of this order, under MCL 484.2203(12). To comply with the Michigan Rules of Court's requirement to notify the Commission of an appeal, appellants shall send required notices to both the Commission's Executive Secretary and to the Commission's Legal Counsel. 
