#### ORDER APPROVING SETTLEMENT AGREEMENT

On September 24, 2020, in Case Nos. U-20892 et al., the Commission issued an order (September 24 order) commencing formal proceedings to revoke the licenses to provide basic local exchange service for the providers listed in Case Nos. U-20892 et al., including Air Advantage, LLC (Air Advantage) pursuant to Public Act 179 of 1991, Michigan Telecommunications Act, MCL 484.2601. The order directed each provider that desired to retain its license to file a petition to intervene by October 26, 2020, and appear at a joint hearing on November 17, 2020, via tele/videoconference. Air Advantage was the sole listed provider to intervene and attend the proceeding and, pursuant to the September 24 order, further proceedings were scheduled in Case No. U-17001, its original licensing docket, to address the potential revocation of Air Advantage's license.

On November 17, 2020, a prehearing conference was held before Administrative Law Judge Sally L. Wallace (ALJ). In accordance with the November 20, 2020 case schedule, an evidentiary hearing was held on March 23, 2021. At the proceeding, the parties' pre-filed testimony and exhibits were bound into the record. On May 12, 2021, the parties notified the ALJ that a settlement had been reached and the ALJ transmitted the matter to the Commission for its consideration.

The Commission has reviewed the settlement agreement and finds that the public interest is adequately represented by the parties who entered into the settlement agreement. The Commission further finds that the settlement agreement is in the public interest, represents a fair and reasonable resolution of the proceeding, and should be approved.

THEREFORE, IT IS ORDERED that the settlement agreement is approved, and the matter of the license revocation proceeding against Air Advantage, LLC, is dismissed without prejudice.
