ORDER

On January 14, 2021, Todd and Penny Allen (Complainants) filed a complaint against Consumers Energy Company (Consumers) alleging that Consumers failed to properly provide electrical service at the Complainants' property. On March 2, 2021, a prehearing conference was held before Administrative Law Judge Kandra K. Robbins (ALJ). On March 29, 2021, a second prehearing conference was held before the ALJ. The second prehearing conference was adjourned and subsequently resumed on April 22, 2021. The April 22, 2021, prehearing conference was also adjourned and subsequently resumed on June 1, 2021. On June 8, 2021, the Complainants filed a request for withdrawal of the complaint with prejudice, and on June 14, 2021, the ALJ transmitted the matter to the Commission for consideration.

The Commission finds that the complaint filed in Case No. U-20973 should be dismissed with prejudice because the parties have reached a settlement agreement and the Complainants requested to withdraw the complaint with prejudice.

THEREFORE, IT IS ORDERED that the complaint filed by Todd and Penny Allen against Consumers Energy Company is dismissed with prejudice.

The Commission reserves jurisdiction and may issue further orders as necessary.

Any party desiring to appeal this order must do so in the appropriate court within 30 days after issuance and notice of this order, pursuant to MCL 462.26. To comply with the Michigan Rules of Court's requirement to notify the Commission of an appeal, appellants shall send required notices to both the Commission's Executive Secretary and to the Commission's Legal Counsel.
