## **ORDER**

On April 10, 2017, Starion Energy NY Inc. (Starion) applied for a license to operate as an alternative gas supplier (AGS) in Michigan pursuant to Public Act 634 of 2002 (Act 634), MCL 460.9 *et seq*. On August 23, 2017, the Commission approved Starion's application in this docket.

On June 30, 2021, Starion requested to voluntarily surrender its license. Starion has not served any customers in Michigan since becoming a licensed AGS. The Commission Staff recommends approval of this request, noting that there are no customers adversely affected by the license surrender.

The Commission finds that the request to surrender Starion's license as an AGS should be approved, along with the release of the company's \$100,000 Letter of Credit. Further, the Commission finds that this docket should be closed.

THEREFORE, IT IS ORDERED that Starion Energy NY Inc.'s license as an alternative gas supplier in the state of Michigan is surrendered, along with the release of the company's \$100,000 Letter of Credit, and this docket is closed.

The Commission reserves jurisdiction and may issue further orders as necessary.

Any party desiring to appeal this order must do so in the appropriate court within 30 days after issuance and notice of this order, pursuant to MCL 462.26. To comply with the Michigan Rules of Court's requirement to notify the Commission of an appeal, appellants shall send required notices to both the Commission's Executive Secretary and to the Commission's Legal Counsel.
