ORDER RESCINDING LICENSE

On August 10, 2020, Sunwave USA Holdings Inc. (Sunwave) applied for a license to operate as an alternative gas supplier (AGS) in Michigan pursuant to Public Act 634 of 2002, MCL 460.9 *et seq.* On November 19, 2020, the Commission approved Sunwave's license in this docket.

On December 27, 2021, Sunwave requested to voluntarily relinquish its license. The Commission Staff (Staff) has confirmed that Sunwave has not served any customers in Michigan since becoming a licensed AGS. The Staff recommends approval of this request, noting that there are no customers that would be adversely affected by the rescission.

The Commission finds that Sunwave's request to voluntarily relinquish its license as an AGS should be approved, along with the release of its \$100,000 bond. Further, the Commission finds that this docket should be closed.

THEREFORE, IT IS ORDERED that Sunwave USA Holdings Inc.'s license as an alternative gas supplier in the state of Michigan is rescinded, the release of its \$100,000 bond is approved, and this docket is closed.

The Commission reserves jurisdiction and may issue further orders as necessary.

Any party desiring to appeal this order must do so in the appropriate court within 30 days after issuance and notice of this order, pursuant to MCL 462.26. To comply with the Michigan Rules of Court's requirement to notify the Commission of an appeal, appellants shall send required notices to both the Commission's Executive Secretary and to the Commission's Legal Counsel.


