ORDER

On January 6, 2023, Branden Lavar Trapp (Complainant) filed a complaint against DTE Energy Company (Respondent) alleging that the Respondent had acted in violation of Mich Admin Code, R 460.154(4). On February 7, 2023, a hearing was scheduled for March 15, 2023, before Administrative Law Judge Christopher S. Saunders (ALJ). On February 27, 2023, the Complainant notified the Commission that he wished to withdraw the complaint. On March 1, 2023, the ALJ transmitted the matter to the Commission for its consideration.

The Commission finds that the complaint filed by Branden Lavar Trapp should be dismissed because the Complainant withdrew the complaint.

THEREFORE, IT IS ORDERED that the complaint filed by Branden Lavar Trapp against DTE Energy Company is dismissed.

The Commission reserves jurisdiction and may issue further orders as necessary.

Any party desiring to appeal this order must do so in the appropriate court within 30 days after issuance and notice of this order, pursuant to MCL 462.26. To comply with the Michigan Rules of Court's requirement to notify the Commission of an appeal, appellants shall send required notices to both the Commission's Executive Secretary and to the Commission's Legal Counsel.
