ORDER

On March 24, 2023, Jerome Schulte (Complainant) filed a complaint against DTE Electric Company. On April 25, 2023, the Complainant filed a request to withdraw his complaint with prejudice.

The Commission finds that the complaint filed by Jerome Schulte should be dismissed with prejudice because the Complainant withdrew the complaint with prejudice.

THEREFORE, IT IS ORDERED that the complaint filed by Jerome Schulte against DTE Electric Company is dismissed with prejudice.

The Commission reserves jurisdiction and may issue further orders as necessary.

Any party desiring to appeal this order must do so in the appropriate court within 30 days after issuance and notice of this order, pursuant to MCL 462.26. To comply with the Michigan Rules of Court's requirement to notify the Commission of an appeal, appellants shall send required notices to both the Commission's Executive Secretary and to the Commission's Legal Counsel.


