**ORDER DISMISSING APPLICATION**

On February 7, 2024, Consumers Energy Company filed an *ex parte* application requesting that the Commission approve a voluntary gain share associated with the sale of certain unregulated assets, including the company's Appliance Service Plan. On July 24, 2024, Consumers filed a request to withdraw its application and to close the docket as the issue raised was resolved in Case No. U-21490.

The Commission finds that Consumers' request to withdraw its application and close the docket is reasonable and should be granted.

THEREFORE, IT IS ORDERED that Consumers Energy Company's request to withdraw its application is granted, and the docket in this proceeding is closed.

The Commission reserves jurisdiction and may issue further orders as necessary.

Any party desiring to appeal this order must do so in the appropriate court within 30 days after issuance and notice of this order, pursuant to MCL 462.26. To comply with the Michigan Rules of Court's requirement to notify the Commission of an appeal, appellants shall send required notices to both the Commission's Executive Secretary and to the Commission's Legal Counsel. 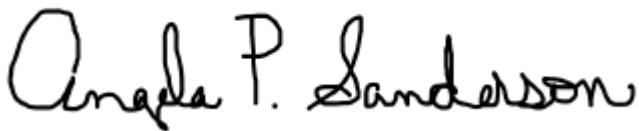
