ORDER

On May 27, 1999, the Commission issued an order in this docket (May 27 order) adopting an initial set of performance measures and benchmarks to be used in reviewing the compliance of Ameritech Michigan, now known as AT&T Michigan, with its obligation to provide nondiscriminatory access to its facilities and services, including unbundled network elements, to competitive local exchange carriers (CLECs). From time to time, the Commission has modified those performance measures and benchmarks in a number of subsequent orders. A collaborative group of interested persons meets during regularly scheduled reviews to refine the performance measures and remedy plan. Participants in those collaborative efforts include AT&T Michigan, interested CLECs, and the staff from state regulatory commissions in Michigan, Illinois, Indiana, Ohio, and Wisconsin. Changes agreed to are presented to the Commission for approval and adoption. The most recent order issued in this docket is the October 5, 2022 order, which

extended the effective date of the then-current performance measures and remedy plan through December 31, 2024.

On August 29, 2024, AT&T Michigan filed a report in this docket on the 2024 performance measures and remedy plan collaborative review (Remedy Plan Report). In its report, AT&T Michigan states that during a collaborative review held via teleconference on August 6, 2024, AT&T Michigan proposed a 2-year extension of the current performance measures and remedy plan. Thus, the new term of the remedy plan would be through December 31, 2026. There were no objections to AT&T Michigan's proposed 2-year extension. Remedy Plan Report, pp. 2-3. If approved, AT&T Michigan and the CLECs will incorporate the extension into their respective interconnection agreements and submit those amended agreements for Commission approval.

In light of the consensus reached by the collaborative participants, the Commission finds that it is reasonable to extend the term of the current performance measures and remedy plan until December 31, 2026. All other provisions remain in effect.

THEREFORE, IT IS ORDERED that the current performance measures and remedy plan, as approved by the Commission in its October 5, 2022 order, is amended to extend its effective date through December 31, 2026.

The Commission reserves jurisdiction and may issue further orders as necessary.

Any party desiring to appeal this order must do so in the appropriate court within 30 days after issuance and notice of this order, pursuant to MCL 462.26. To comply with the Michigan Rules of Court's requirement to notify the Commission of an appeal, appellants shall send required notices to both the Commission's Executive Secretary and to the Commission's Legal Counsel. 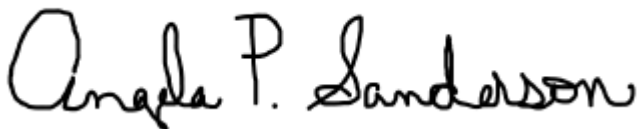
