**ERRATA**

Due to an error, the April 10, 2025 order (April 10 order) in the above-captioned case misstated the proper net underrecovery amount in ordering paragraph C on page 15. The correct net underrecovery amount is \$415,386,293, inclusive of interest, and shall be the amount reflected as Consumers Energy Company’s 2023 power supply cost recovery reconciliation beginning balance. In addition, due to an error in the April 10 order, on page 11, the following sentence appeared: “The Commission further finds that Consumers properly removed \$2,202,362 of replacement power costs related to the Toshiba work.” The amount stated as \$2,202,362 was in error and should have read \$2,329,167. Therefore, the sentence on page 11 of the April 10 order is corrected to read: “The Commission further finds that Consumers properly removed \$2,329,167 of replacement power costs related to the Toshiba work, as reflected in revised Exhibit S-1.”


