ORDER

Public Act 179 of 1991, as amended, created the Michigan Telecommunications Act (MTA) and provides that the Commission “shall maintain a publicly available database of providers in each exchange that are licensed to or otherwise provide toll and local exchange service in this state.” MCL 484.2103(2). The MTA requires providers to “submit to the commission all information requested by the commission necessary for the preparation and maintenance of the database under [MCL 484.2103(2)].” MCL 484.2103(3).

Pursuant to MCL 484.2103(2), the Commission provides a publicly available database (public database) through a partnership with Connect Michigan, LLC (also known as Connected Nation Michigan) (collectively CN-Michigan).¹ In light of the increased use of unregulated

communications services, it is important for the Commission and customers to have a clear understanding of the changes that are being made to the service area where a provider offers basic local exchange service (BLES). While there have been many advances made in the availability of telecommunications and broadband services, there are still areas within Michigan that lack broadband service, may not have reliable wireless voice service, and where other types of non-regulated services such as voice over internet protocol (VoIP) service are not yet available. As a result and pursuant to MCL 484.2103(3), the Commission directs all licensed telecommunication service providers who provide BLES in the state of Michigan to provide updated geographic information listing where that service is available to customers within an exchange and to update that information whenever they modify their BLES service area, whether that modification is to an entire exchange or to a portion thereof. If a telecommunication service provider has not discontinued BLES service, but is no longer offering BLES to new customers, that provider shall identify those specific areas and provide the Commission with the geographic areas impacted by that change.

The Commission hereby opens this docket for the collection of updated data and seeks comment from all interested persons regarding the timing and format of the BLES service area information to be collected. To ensure that the information for the public database is provided in a consistent, accurate, and usable format, the Commission specifically seeks comment regarding the following proposals for the submission of the BLES service area data:

- Requiring the BLES service area data to be provided in ESRI Shapefile, ESRI Geodatabase, or KMZ format.
- Requiring the BLES service area data to be provided directly to the Commission in two separate files: (1) the first file would include the current BLES service area (telephone service and exchange areas) and (2) the second file would include the revised BLES service area. The datasets must identify the provider's name and specify whether the data are associated with residential

customers, business customers, or both customer types.

- For changes to a BLES service area that occurred prior to the Commission issuing its next order in this docket, requiring all Michigan licensed BLES providers who offer the service to provide current geographic mapping information to the Commission of any changes to their existing BLES service area within 60 days from the date the Commission issues its next order in this docket to implement these requirements. Change in the availability of BLES service includes, but is not limited to, limiting the availability of BLES service to customers through grandfathering of service, discontinuation of service, or the application of 47 CFR 63.71 (including 47 CFR 63.71(g)).
- For changes to a BLES service area that occur on or after the Commission issues its next order in this docket, requiring all Michigan licensed BLES providers who offer the service to provide updated geographic mapping information to the Commission reflecting any modification to their BLES service area (regardless of whether the modification is to an entire exchange or to a portion thereof) within 30 days of the modification taking effect.
- This order will primarily impact Incumbent Local Exchange Carriers (ILECs), as defined in Section 251(h) of the Telecommunications Act of 1996, 47 USC 251(h), as the ILECs are the providers that were initially licensed in each exchange, and many Competitive Local Exchange Carriers (CLECs) choose to mirror the territory of the ILECs. However, there may be circumstances in which a CLEC only offers or provides service in a portion of an ILEC's service territory. The Commission seeks specific comment on:
 - Requiring the same BLES service area data from both CLECs and ILECs under the specified timeframe as noted within this order.
 - A CLEC's capability of continuing to provide BLES in areas where the ILEC may no longer offer or provide BLES service.

Any person may submit written comments on the proposed process for receipt of updated BLES service area data. All comments should be paginated, reference Case No. U-21869, and must be received no later than 5:00 p.m. (Eastern time) on June 13, 2025. Written comments should be mailed to: Executive Secretary, Michigan Public Service Commission, P.O. Box 30221, Lansing, MI 48909. Electronic comments should be e-mailed to: LARA-MPSC-Edockets@michigan.gov. If any person requires assistance prior to filing, they may contact the Commission Staff at (517) 284-8090 or by e-mail at LARA-MPSC-Edockets@michigan.gov. All

information submitted to the Commission in this matter will become public information available on the Commission's E-Dockets website (either under the Filings or Case Comments section), will be subject to disclosure, and will be filed in Case No. U-21869.

THEREFORE, IT IS ORDERED that any person may file written comments regarding the proposed timing and format of the basic local exchange service area information to be collected pursuant to MCL 484.2103(3). To be considered, all comments must be received at the Commission no later than 5:00 p.m. (Eastern time) on June 13, 2025 and should be paginated and reference Case No. U-21869.

The Commission reserves jurisdiction and may issue further orders as necessary.

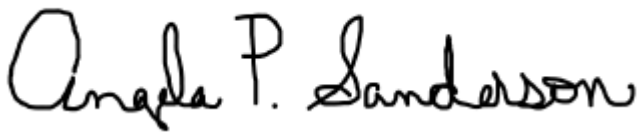
