ORDER

The following parties have filed joint applications for approval of amendments to
interconnection agreements:

Case No. U-15585	AT&T Michigan and Access One, Inc. Application filed April 28, 2026, for approval of a seventh amendment to the interconnection agreement (replaces the 911 attachment with updated terms and conditions allowing the originating service provider (a/k/a dial tone providers) to deliver its traffic to the NG911 delivery point in IP-based SIP format, as required by law).
Case No. U-16116	AT&T Michigan and Liquid Web, LLC Application filed April 28, 2026, for approval of a third amendment to the interconnection agreement (replaces the 911 attachment with updated terms and conditions allowing the originating service provider (a/k/a dial tone providers) to deliver its traffic to the NG911 delivery point in IP-based SIP format, as required by law).

Case No. U-21641	AT&T Michigan and First Communications, LLC Application filed April 28, 2026, for approval of a second amendment to the interconnection agreement (replaces the 911 attachment with updated terms and conditions allowing the originating service provider (a/k/a dial tone providers) to deliver its traffic to the NG911 delivery point in IP-based SIP format, as required by law).

47 USC 252(e)(2) and (3) provides in part:

- (2) The State commission may only reject--
 - (A) an agreement (or any portion thereof) adopted by negotiation under subsection (a) if it finds that--
 - (i) the agreement (or portion thereof) discriminates against a telecommunications carrier not a party to the agreement; or
 - (ii) the implementation of such agreement or portion is not consistent with the public interest, convenience, and necessity; . . .
- (3) Notwithstanding paragraph (2), but subject to section 253 of this title, nothing in this section shall prohibit a State commission from establishing or enforcing other requirements of State law in its review of an agreement, including requiring compliance with intrastate telecommunications service quality standards or requirements.

After reviewing the applications, the Commission finds that they should be approved. The Commission finds that the amendments are consistent with federal and state law and are in the public interest. Under 47 USC 252(i) and MCL 484.2359(2), the services provided under the agreements shall be made available to other telecommunications carriers upon the same terms and conditions.

THEREFORE, IT IS ORDERED that:

- A. The interconnection agreement amendments listed above are approved.
- B. Approval of the interconnection agreement amendments does not alter the duty of the parties to comply with relevant federal and state law and past and future Commission orders and rules.

The Commission reserves jurisdiction and may issue further orders as necessary.

Any party aggrieved by this order may file an action in the appropriate federal District Court under 47 USC 252(e)(6). To comply with the requirement to notify the Commission of an appeal, appellants shall send required notices to both the Commission's Executive Secretary and to the Commission's Legal Counsel. 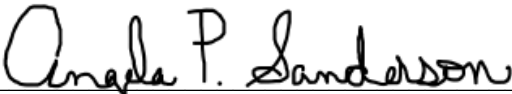
