COMMENTS OF THE MICHIGAN PUBLIC SERVICE COMMISSION IN SUPPORT OF SBC MICHIGAN'S REQUEST FOR MODIFICATION OF LATA BOUNDARIES

Pursuant to the Federal Communications Commission's ("FCC") procedural schedule established in the above docket, the Michigan Public Service Commission ("MPSC") hereby submits its comments.

I. INTRODUCTION

On February 5, 2004, the FCC requested comments regarding nine petitions submitted by SBC Michigan requesting modification of local access and transport area ("LATA") boundaries.¹ Granting the petitions would allow SBC to provide flat or message-rated, non-optional expanded local calling service to exchanges currently separated by federally-mandated LATA lines.²

II. DISCUSSION

Each of the nine petitions was accompanied by the MPSC order³ requiring Michigan carriers to implement expanded local calling in compliance with the Michigan Telecommunications Act ("MTA").⁴ In addition, SBC Michigan received approval from the FCC to provide in-region long-distance services, within and across LATA boundaries pursuant to Section 271 of the Federal Telecommunications Act ("Section 271") on September 19, 2003.⁵ Prior to receiving Section 271 approval, SBC Michigan could not transport local or long distance calls across LATA boundaries.

On April 29, 2003, the FCC approved 55 SBC Michigan petitions to provide local calling between specific exchanges or geographic areas.⁶ With the current petition, SBC Michigan is requesting approval to complete local calls across LATA boundaries, in accordance with the MTA and the Section 271 approval, to ensure that the intention of the Michigan legislature and the desire of Michigan customers are brought to fruition.

By granting the petitions, the FCC furthers consumer expectations for adjacent exchange local calling areas and allows for additional choices in telecommunications carriers.
