Commission Staff Cindy Creisher, Energy Operations Division, presented a brief synopsis of the case listed above. Commissioner Saari moved that the Commission approve the order at its August 28, 2018 meeting. Commissioner Eubanks seconded that motion.

Commissioner Saari commented:

"Approval of the settlement agreement in the Consumers Energy natural gas case before us today resolves financial issues requested by the utility.

My observation is that the settlement does not address the increased attention and actions needed to further enhance natural gas pipeline safety programs.

Michigan has an aging natural gas pipeline system. While it is operated safely now, the system will continue to face increased operational stress, as well as scrutiny by federal and state regulators to make sure that best practices are adopted and adhered to and that needed pipeline system repairs and replacement is accomplished in an efficient and timely manner.

It will be encouraging to see the utilities increase their focus and public awareness of pipeline safety programs.

The highly success national one-call system to stake and locate underground gas lines before you excavate had its origins in Michigan. The original MISS DIG system has been strengthened into the Common Ground Alliance program, and the 8-1-1 one-call system enjoys widespread success. Let's

not rest on the program's legacy and assume it will continue successfully without needed public information and proper staking techniques. We applaud Consumers Energy for its efforts and urge them to continue implementing best safe work practices.

We also ask that Consumers Energy gas increase its focus and awareness of another successful national gas safety program. It's called SMS, or Safety Management System, and has widespread support from the PHMSA, NAPSR, AGA, INGAA, API and other government and industry associations who deal with pipeline safety programs.

SMS is fundamental to a needed safety culture. I'm disappointed that Michigan utilities do not fully publicly embrace this program and recognize its outstanding value. It's not an enforcement tool but a widely recognized series of national guidelines to help enhance pipeline safety.

Its program is very basic – Plan, Do, Check, Act. It's a common sense approach to put safety thinking in place before and during the work process.

It's not cost prohibitive, it's not separate from what a utility should already be doing for safety programs, and it improves and enhances the needed focus on safety.

Amidst the Consumer's Triple P policy and its clean and lean sloganeering, I am hopeful that the culture of adopting Safety Management System programs find the same focus in rally rooms, objective setting and quarterly reviews at the utility."
