# Commissioner Phillips announced:

"Thank you, Chair Scripps. Today, we have for our consideration order U-20935, which if supported by the Commission, would approve DTE Electric Company's ex parte application for a regulatory asset and other associated program components related to Phase Two of the Company's Electric Vehicle Charging Forward Program.

The Phase Two pilot proposal, as outlined in DTE's application, is an important building block to the further support and exploration of the grid-related challenges and potential customer and system-wide benefits associated with the rapid electrification of the transportation sector. The proposed expanded EV pilot also complements the recently extended Consumers Energy electric vehicle pilot program approved by the Commission in December of last year.

The order before us approving the Company's application will allow for the increased support of vehicle electrification among commercial and industrial customers in the Company's service territory.

The order also emphasizes the need for the DTE Electric to include as a part of its next general rate case comprehensive pilot plan and associated objective pilot criteria as outlined in case U-20645 issued by

the Commission on February 4<sup>th</sup> of this year. Submission of this comprehensive pilot plan and objective criteria will provide the Commission with greater transparency of the Company's Phase Two proposal as well as a better understanding of the Company's plans to implement the Charging Forward program at full scale after the pilots have concluded."

# **Chair Scripps announced:**

"Our next meeting is scheduled for Thursday, April 8, 2021 at 1:30 pm. Under the extensions that were approved last year by the Legislature, this meeting would need to be in person unless a local emergency declaration exists, in this case for Eaton County, where the Commission offices are housed. Earlier this week the Eaton County Board of Commissioners adopted such a declaration, and while we're still reviewing the language and impact, it is likely that we will continue to meet virtually, at least for the April 8 meeting. We've seen significant benefits at the Commission from both a safety and transparency perspective from being able to meet virtually and will continue to update you on any changes and our plans as we go forward.

I also want to recognize that March is Women's History Month, and we have been celebrating the many contributions of women Commissioners and Staff all month through social media channels and in other ways. I know Commissioner Peretick in particular is a relentless supporter of women in STEM, and that commitment is shared by all of us. It is an exciting opportunity to recognize, again, the many, many contributions of women who have served in both Commissioner and Staff roles here at the Commission and added to our work.

Finally, I want to express condolences from the Commission to victims of the recent killings in Atlanta, and to the Asian American community more broadly. There are certainly some troubling trends in terms of violence against the Asian American community, and I'd note that 70% of the victims last year in an analysis of more than 4000 hate-related incidents – 70% were women. So, again, I want to express the condolences of the Commission to the victims and their families and to the broader community."

## **Commissioner Phillips announced:**

"Chair, I would just like to take a brief moment to recognize the concerns raised by members of our Staff about the rise in hate speech and violence nationally towards the Asian American community, in part, due to rhetoric related to the origins of the novel coronavirus.

The recent violence perpetuated against Asian Americans in San Francisco, New York, and other communities across the country only strengthens our organizations commitment to talk openly and genuinely about how the Commission can and will address discrimination and promote inclusion within the virtual walls of the of our organization and externally in the jurisdictions we regulate.

I continue to encourage our Staff to speak up and to speak out, and once again thank those who have contributed to our organization's diversity and inclusion efforts. I also lend praise to the individuals and organizations who are working to protect and advocate for those communities who are being impacted by this heightened state of hate speech and violence towards the Asian American community."

### **Commissioner Peretick announced:**

"I just wanted to second the thoughtful comments of the other two Commissioners – Chair Scripps and Commissioner Phillips and express condolences. I also want to express our commitment to diversity, equity, and inclusion at the Commission."
