# 3. U-21015 IN THE MATTER OF THE APPLICATION OF DTE ELECTRIC COMPANY FOR FINANCING ORDER APPROVING THE SECURITIZATION OF QUALIFIED COSTS (final order)

Commission Staff Bob Nichols, Regulated Energy Division, presented a brief synopsis of the case listed above. Commissioner Phillips moved that the Commission approve the order at its June 23, 2021 meeting. Commissioner Peretick seconded that motion.

#### Chair Scripps commented:

"I would like to thank Mr. Nichols and the staff involved in this preceding, as well as the parties to this case. These cases have a mandatory 90-day statutory timeline that are inherently tight, involving a lot of moving parts in a short amount of time. I think the quality of the testimony and the briefing by the participants in this case and a well-run process by Administrative Law Judge Mack was of great benefit in highlighting the issues and allowing us to meet our statutory obligations in issuing today's order.

This is the fourth securitization case under the 2000 Act, as Mr. Nichols mentioned, involving balances relating to retiring of power plants and the first involving costs associated with tree-trimming surge programs that are needed as part of our continuing focus on improving the reliability of the distribution system. The storms that we have saw earlier this week highlight how important those efforts are. When looking across the cases, including the order before us today, securitization has demonstrated real benefits for customers and balanced against the regulatory certainty and ability to recover prudently incurred obligations from the utilities. I think there is a lot in this order that is admirable, particularly given the tight timelines. Again, I want to thank our staff and the other participants in this case for their efforts."

Commissioner Phillips moved that the Commission approve the order at its June 23, 2021 meeting. Commissioner Peretick seconded that motion.

#### V. PUBLIC COMMENTS

Glen Kowalske indicated that he wanted to provide comments in the chat feature. He was unsuccessful in conveying his comments during the Commission Meeting due to technical difficulties. Cathy Cole, Commission staff, indicated that she would provide guidance for Mr. Kowalske to submit comments to the Commission offline.

Chair Scripps announced:

"The local State of Emergency declared by the Eaton County Board of Commissioners comes to an end at 11:59 p.m. on July 1<sup>st</sup>. We have a meeting scheduled for 10:30 a.m. on Friday, July 2<sup>nd</sup>. As a

result, this July 2<sup>nd</sup> meeting will be held at the Commission's office at 7109 West Saginaw Hwy., Lansing at the Commission building. While we are excited that we are at this place in the pandemic where we believe that it is safe to reopen and some of the emergency orders are being lifted both at the county and state level. I am personally excited for the opportunity to welcome back the public in-person and perhaps move past some of these technical challenges. It is sad that the era of attending these Commission Meetings in flip flops is likely coming to a close. As we transition back to in-person meetings and meeting our commitments and obligations under the Open Meetings Act, we have learned a lot through the pandemic. I think that some of the tools that we now have in our toolbox, in terms of utilization of technology, can continue to be of use as we return to have the opportunity to use for the public to attend these meetings in-person. Particularly, using this TEAMS platform to allow folks from every corner of the state to participate in real-time in our meetings without having to drive to Lansing is a benefit. Even as we return to in-person meetings, there will also be an option to participate in the July 2<sup>nd</sup> meeting, and future meetings by telephone or by using the Microsoft TEAMS electronic platform. We encourage you to take advantage of the virtual option. It is something that I have seen the benefits of throughout the last 15+ months.

My second announcement is that we are hiring. We have an open position as a Departmental Analyst in our Compliance and Investigation Section that is housed in our Customer Assistance Division. This position will perform research and analysis related to rate recovery cases before the Commission, as well as being responsible for working with the public via telephone, mail, and email. The Departmental Analyst will act as a negotiator and mediator to resolve disputes between the utility companies or alternative energy providers and customers, as well as performing investigations as needed to address issues and assist in resolution. This is an active, open position with the Commission. It closes tomorrow at 5:00 p.m., June 24, 2021. I encourage anyone who is interested to apply."

Commissioner Phillips announced:

"First, you can still wear sandals to our Commission Meetings held in-person. I just don't know if it is encouraged.

Secondly, I wanted to thank everyone from utility linemen, to contractors, managers, and executive teams at our major utilities in this state for the tremendous work that you did this past weekend in helping to ensure reliability of customers throughout your service territories and restoring power to the 150,000+ customers who lost power due to the 3 waves of storms that we received in I&M, Consumers, and DTE service territories. You have been working with us to increase the responsiveness and communication on the recovery process during storm events like this. It is my favorite time of year. I love being able to view and monitor these severe events, but it certainly has implications for our electricity system. You have done a tremendous job this past week to have folks restored in a timely and efficient manner. This bodes well to further events as the year proceeds. Thank you, Chair."
