- 1. U-20822 IN THE MATTER OF THE APPLICATION OF SEMCO ENERGY GAS COMPANY FOR AUTHORITY TO IMPLEMENT A GAS COST RECOVERY PLAN AND FACTORS FOR THE 12-MONTH PERIOD FROM APRIL 2021 THROUGH MARCH 2022 AND FOR RELATED APPROVALS (proposed settlement agreement)

Case No. U-20822 involves an application filed by SEMCO Energy Gas Company for approval of a gas cost recovery plan and authorization of gas cost recovery factors for the 12 months ending March 31, 2022. The order before you approves a settlement agreement resolving all issues in the case. Commissioner Phillips moved that the Commission approve the order at its November 18, 2021 meeting. Commissioner Peretick seconded that motion.

Chair Scripps commented:

"Before we move to the vote on this matter, I want to note that that the Commission recognizes that the increased gas cost recovery factor included in the settlement agreement before us will result in higher bills for Michigan families and businesses, which is - of course - a particular concern as we head into the winter months. This reflects the increase in the underlying commodity cost of natural gas, which has gotten a fair amount of attention recently.

We will continue to focus on this issue, including reviewing utility gas procurement practices, to encourage efforts to mitigate these increasing natural gas prices. Some of the strategies already in use include utilizing Michigan's unique geological features to store gas – allowing utilities to purchase the gas when it is less expensive in a way that provides savings to customers – as well as using First Of Month pricing secured just prior to the start of the month to lock in the index price premium at specific locations at the beginning of the month providing additional stability and protection from real time price volatility.

But that doesn't change the fact that gas bills are going up.

In the meantime, for those struggling with energy bills this winter, we encourage you to reach out to your provider to see what options are available in the form of affordable payment plans. In addition, you can learn about available assistance programs by calling 2-1-1, visiting MI211.org, or going to the Commission's website at <u>www.Michigan.gov/mpsc</u> to learn more and be connected with assistance providers in your community."

We will have additional details on the public hearing shortly after the Thanksgiving holiday."

Commissioner Phillips announced:

"As many have heard, Michigan has the unfortunate distinction, once again, of having some of the most significant increases in COVID-19 cases nationwide just ahead of the holidays. I am asking the Commission, family, as well as others in the community to stay vigilant, become vaccinated or receive the booster shot, if you are so inclined. Make sure to take care of yourselves and your families over the holidays."

Commissioner Peretick announced:

"Thank you to staff and stakeholders who participated in our technical conferences on electric reliability and storm response. I thought they were very successful, and I look forward to implementing some of the recommendations and ideas that were generated."
