Commissioner Phillips commented:

"I would like to thank Ms. Armstrong, the staff, and team members that you worked with, as well as the stakeholders who you engaged with throughout the convening of the EAAC collaborative. I would like to note a couple of thoughts that were particularly innovative regarding the collaborative. Your working relationship with other staff in the EWR low-income working group was an occasion where there could have been egos and fights over turf regarding a lot of this affordability and access work, but all of you really took a genuine look at where your mutual efforts could build upon one another. I think the result of this work has really improved regulatory efforts here at the Commission and improved access to services for customers in need all across the state. I really want to thank you for that and the genuine relationship that all of you have built with stakeholders who have participated in the EAAC collaborative. Not only are those stakeholders brought to the table to provide input to all of you, but during that process you all also provided the opportunity for those stakeholders to ask questions, present urgent needs that they had with families that they were assisting through their mutual organizations and allowed for those stakeholders to have those questions answered are those problems addressed during those collaborative meetings. Again, you really built that genuine responsive relationship that I think is a model for other collaboratives and work groups that we may convene in the future.

Lastly, I will just say that through the last two years of this effort, it is clear through some of the data that we have been collecting on arrearages and shut offs, your work has really helped in easing the financial stress for allowing for homeowners and families across the state to be more comfortable during the winter months throughout these last two years. I applaud you for those efforts connected to this docket, but also the efforts of your team and staff members throughout what has been a really difficult last two years. I know that this has been a lot of work getting to this point. We are really proud of the recommendations that have been put forth here. Again, I applaud this work and encourage the ongoing nature of this collaborative going forward. Thank you."

V. PUBLIC COMMENTS

Alyssa Hayes commented on the carbon offset program, her concerns about climate change, and keeping the current nuclear power plants open in Michigan.

Chair Scripps announced:

"It is report season at the Michigan Public Service Commission. Earlier this month on February 1st, as required by Statute, we submitted to the Legislature a report on the Status of Competition for Video Services in Michigan, as well as a Status of Electric Competition report. Both of those press releases and the accompanying reports are available on our website at www.michigan.gov/mpsc. In the coming weeks we will also be releasing reports on Renewable Energy in Michigan, our Energy Waste Reduction Plan, as well as the Commission's Annual Report. I am probably missing some, but we will make these publicly available, as well sending them to our partners in the Legislature for full transparency of the work of the Commission. I encourage you to take a look at those as well.

On February 1st, we celebrated the Lunar New Year, also known as the Chinese New Year. February 1st also kicks off Black History Month where we celebrate the many contributions of black Michiganders throughout the month. It is always a good thing to mark, remember, and celebrate.

Finally, there has been a lot of focus on energy affordability and assistance today between the order and the presentation in U-20757 around the EAAC, as well the Percentage of Income Pilot Program in U-21021. "I would like to offer an acknowledgement and a congratulations to Shatina Jones who was recently hired as the MPSC's first ever Diversity, Equity, and Inclusion Officer. Ms. Jones has worked for the MPSC since 2008 and was Chair of the efforts to refocus its work addressing diversity, equity, and inclusion matters. She will continue that important work in the new leadership role. Please welcome and congratulate Ms. Jones as you are able."
