Commission Staff Kayla Gibbs, Energy Resources Division, presented a brief synopsis of the case listed above. Commissioner Phillips moved that the Commission approve the order at its May 12, 2022 meeting. Commissioner Peretick seconded that motion.

Chair Scripps commented:

"I would like to raise up a few things that Ms. Gibbs covered. First, kudos to the parties, Upper Michigan Energy Resources Corporation, Attorney General Nessel, the Citizens Utility Board, Savion, and the Michigan Public Service Commission staff for their work in reaching what I think is a forward-looking settlement proposal. It includes 100 megawatts of solar, 1.5% energy waste reduction, exclusive of Tilden and other customers who self-direct their own energy waste reduction programs.

Looking at this, I think the combination of resources provides valuable diversity to the Upper Peninsula's energy mix and a hedge against increasing natural gas prices, while trying to utilize the 10 RICE units that Ms. Gibbs described. I think it adds to our resource adequacy in the Upper Peninsula and ultimately is a win, not only for the customers of UMERC but also for customers across the Upper Peninsula.

I appreciate the work of the parties involved in reaching this settlement."

Case No. U-21227 involves a matter, on the Commission's own motion, to initiate a comment period regarding the funding and assistance opportunities available to public utilities pursuant to the federal Infrastructure Investment and Jobs Act of 2021. The order before you sets deadlines for filing comments, as described in this order. Commissioner Phillips moved that the Commission approve the order at its May 12, 2022 meeting. Commissioner Peretick seconded that motion.

Commissioner Phillips commented:

"The Infrastructure Investment and Jobs Act, as we all know, but I think it requires some further emphasis and reiteration, is the impetus for a historic level of federal investment in our nation's infrastructure, and such a significant investment will require an equally historic response from state and local public agencies as well as the private sector in Michigan to not only comprehensively assess and pursue out these resources, but also ensure that when the funds are deployed, we are maximizing their potential financial and societal impacts for all residents of our great state.

The programs now being created and made available through the Department of Energy and other federal agencies will have multi-generational impacts on our environment, our climate, our built infrastructure, and our communities, so I encourage us all to keep the gravity of this opportunity in mind and we thank in advance the stakeholders and regulated entities for their thorough responses, insights, and guidance filed via comments in this docket."

Commissioner Peretick commented:

"I'd like to thank the Attorney General and Citizens Utility Board for their joint letter bringing this opportunity to the forefront, and I look forward to seeing what is possible for infrastructure funding for our state. I'm particularly excited to hear from Kate Gordon, Senior Advisor to Energy Secretary

Jennifer Granholm, who will be presenting on the opportunities available from the Department of Energy later in this meeting."

Chair Scripps commented:

"I want to briefly thank staff and Cartier Energy, as well as Detroit Thermal for their work in reaching the settlement. It is always exciting to see new investment, both in the City of Detroit and in the state of Michigan. We welcome Cartier Energy to Michigan and look forward to seeing their success going forward."

Case No. U-21220 involves an application filed by Detroit Thermal, LLC, for *ex parte* approval of a steam sales agreement for the supply of steam between Detroit Thermal, LLC, and the State of Michigan. The order before you approves the steam sales agreement. Commissioner Phillips

moved that the Commission approve the order at its May 12, 2022 meeting. Commissioner Peretick seconded that motion.

Commission Peretick commented:

"I'd like to introduce Kate Gordon, Senior Advisor to Secretary Jennifer Granholm. Kate has spent the past two decades working at the intersection of climate change, energy policy, and economic development, and is currently spearheading efforts at the Department of Energy to implement the funding made available by the federal Infrastructure Investment and Jobs Act. Kate will describe the funding available to the State of Michigan and to the energy and telecommunication utilities that we regulate."

V. PRESENTATION ON THE INFRASTRUCTURE INVESTMENT AND JOBS ACT BY U.S. DEPARTMENT OF ENERGY, KATE GORDON, SENIOR ADVISOR TO THE SECRETARY

Chair Scripps commented:

"That is really great Kate. I appreciate the thorough overview and the additional detail in the slides, which we will post on our website and make publicly available. It is a great resource."

Commissioner Phillips commented:

"Thank you for the very thorough presentation. We certainly want to send this presentation out to our other colleagues and other agencies to make them aware and make sure that we are all on the same page. This is really a whole government collaborative that we are engaged in to pursue these dollars.

Just a personal comment, I was speaking with a former colleague several weeks ago about our past work (15+ years ago) with the Apollo Alliance. This was the type of investment that was discussed at that time. You were really a thought leader around in terms we need, revolutionary levels of investment, but that investment in clean energy and distributed energy systems and decarbonization needs to be joined along the goals of energy justice on equitable access. I am really proud and thankful that you are in a leadership position to be able to help to not only develop, but to dispense some of these dollars. Now we are actualizing some of those grand concepts of almost two decades ago.

Thank you for reaching out and being able to be here with us once again in this really important time. Certainly, I think we are all on call whenever you need insight from the Great Lakes state. 1we are excited to get some of these dollars deployed to communities and do what we can under a really compressed timeline here."

Chair Scripps commented:

"Thank you so much for making time to share your expertise and your passion and hopefully, some of those federal dollars with us. This is a great resource and one that I think we will be going back over and over again. I cannot wait to get back upstairs and bookmark that website.

Again, I appreciate you joining us."

VI. PUBLIC COMMENTS

A public comment was entered in the chat feature during the previous presentation noting that an RFI for energy storage demonstrations that came out this week and a link was provided.

Chair Scripps announced:

"May is Asian American and Pacific Islander Heritage Month, which honors the arrival of the first Japanese people that migrated to the United States in 1843. It also marks the anniversary of the transcontinental railroad's completion, which is celebrated on May 10, 1869, to honor the Chinese immigrants that laid the tracks. Asian Americans and Pacific Islanders worldwide are an integral and respected part of their communities, making meaningful contributions to academia, business, medicine, law, technology, government, science, and social justice. That is certainly true here at the Michigan Public Service Commission.

Last year on May 18th, Governor Whitmer proclaimed that day as Asian American and Pacific Islanders Day against bullying and hate. It is also the birthday of Vincent Chin, a Highland Park, Michigan resident who was the victim of a hate crime in 1982. His tragic murder inspired a National Asian American and Pacific Islander activist movement that continues to this day.

There are a number of events taking place throughout the state in celebration of Asian American and Pacific Islander month and would specifically highlight a virtual celebration taking place this evening from 6:30 – 8:30 p.m. It will feature remarks from Governor Gretchen Whitmer and keynote speeches from national leaders. There is an opportunity to register. You can search Asian Pacific American Heritage Month Day celebration and there is a link there.

May is also Mental Health Awareness Month, which has been observed in May in the United States since 1949. It was started by the Mental Health America organization, which was then known as the National Association for Mental Health. Each year, in mid-March, Mental Health America releases a toolkit of materials to guide preparation for outreach activities during Mental Health Awareness Month. During the month of May, Mental Health American and its affiliates and other organizations interested in mental health, conduct a number of activities which are based on a different theme each year. This year's theme is Back to Basics. It was chosen for 2022 with a goal of providing foundational knowledge about mental health and information about what people can do if their mental health is cause for concern.

Our final announcement is that earlier today we celebrated our Employee Recognition Awards. It is an annual opportunity to celebrate the many contributions of our staff. We start by celebrating those folks who have five years of service to the State and that included, among our staff, Nick Abraham, Erik Hanser, Kristen Kenyon, Ethyan Kramer, Karen Krueger, and Ryan Wilson. For ten years of service in the State, we recognized Anne Armstrong, Kelly Barber-Dodge, Lynn Beck, Taylor Becker, Stephanie Haney, David Isakson, Amber McGrath, Bob Nichols, Naomi Simpson, Tim Witt, and Tim Wolf. Celebrating fifteen years of service with the State were Linda Brauker, Cathy Cole, Roger Doherty, Karen Gould, Jesse Harlow, Jim LaPan, Teresa McMillan-Sepkoski, Dolores

Midkiff-Powell, Mark Pung, Chuck Putman, Nyrhe Royal, Jill Rusnak, Barbara Kunkel, and Staci Sova.

We also, as Commissioner Phillips mentioned earlier in the meeting, provided some Special Recognition awards, including Kayla Gibbs, Resource Optimization and Certification Section, within the Energy Resources Division, Erik Hanser, Energy Market Section, within the Strategic Operations Division, Barry Harmon, Rates and Financial Analysis Section, Telecommunications Division, and Drew Simon, Compliance and Investigation Section, Customer Assistance Division. We also issued our Employee of the Year/Outstanding Service Award to Kasey Patrick, Executive Business Section, Regulatory Affairs Division for her work as a database administrator for E-Dockets, designing and creating the new database for the gas pipeline safety work, and orchestrating the migration to MILogin for the Customer Assistance Division and the Telecommunications Division around customer complaints and inquiries.

Finally, because we also like to have a little fun with this, we had our first-ever auction where we auctioned off homemade bread and jam, honey from a backyard apiary, a hand-drawn likeness of Michigan Public Service Commission's Chief Operating Officer Mike Byrne. You really have to see it to believe it. Homemade mittens made from old sweaters with a fleece lining from Executive Secretary, Lisa Felice, which she noted were fleece lined and Felice made. All told, we raised more than \$500 which will be contributed to one of the Michigan Energy Assistance program grantees that provide energy assistance to low-income Michiganders. My cheeks hurt from smiling and laughing so much. It is a wonderful organization with a great, great staff that works everyday for the benefit of Michiganders. We try to celebrate them every day, but we certainly want to make sure that we do it on an annual basis."

Commissioner Phillips announced:

"Thank you Chair for recognizing Asian American and Pacific Islander Month and just say that as a Commission body, as well as an organization, we recognize the increased anxieties that many withing the Asian American and Pacific Islander population currently are experiencing in relation to increased discrimination and violence that has been experienced for individuals of that community, particularly, since the beginning of the COVID-19 pandemic. We want to say that we recognize that. We are certainly taking steps to better understand how and address instances of discrimination within the Asian American and Pacific Islander community within our organization and ensure that we are creating an environment that is inclusive of all populations and all ethnicities here at the Commission. I just wanted to make sure that particular note given this time period of increased tensions, and unfortunately, violence towards the Asian American and Pacific Islander community.
