IN THE MATTER, ON THE COMMISSION'S OWN MOTION, TO SEEK COMMENTS FROM RATE-REGULATED ELECTRIC, STEAM, AND NATURAL GAS UTILITIES REGARDING POTENTIAL UTILITY INFRASTRUCTURE IMPROVEMENTS IN THE STATE OF MICHIGAN FROM THE FEDERAL FUNDING AVAILABLE UNDER THE INFRASTRUCTURE INVESTMENT AND JOBS ACT OF 2021: ALPENA POWER COMPANY, CONSUMERS ENERGY COMPANY, DETROIT THERMAL, LLC, DTE ELECTRIC COMPANY, DTE GAS COMPANY, INDIANA MICHIGAN POWER COMPANY, NORTHERN STATES POWER COMPANY, UPPER PENINSULA POWER COMPANY, UPPER MICHIGAN ENERGY RESOURCES CORPORATION, MICHIGAN GAS UTILITIES CORPORATION, AND SEMCO ENERGY GAS CORPORATION (interim order)

Case No. U-21227 involves a matter, on the Commission's own motion, to initiate a comment period regarding the funding and assistance opportunities available to public utilities pursuant to the federal Infrastructure Investment and Jobs Act of 2021. The order before you summarizes comments received in response to the May 12, 2022 order in this docket and issues guidance related to the federal Infrastructure Investment and Jobs Act of 2021 moving forward. Commissioner Phillips moved that the Commission approve the order at its August 23, 2022 meeting. Commissioner Peretick seconded that motion.

Commissioner Peretick commented:

"I want to thank everyone who submitted comments regarding implementation of the IIJA in response to our request in this docket. Ensuring that we in Michigan are able to maximize the federal funding opportunities available through the IIJA is a priority, and I'm looking forward to receiving updates on funding applications and seeing some of the \$550 billion available for infrastructure improvements spent in our state.

In the comments we received, we saw common areas of interest and potential collaboration between utilities and other stakeholders for grid flexibility, reliability, resilience, and accessibility in rural and remote areas; renewable energy investment and deployment including hydrogen and battery storage projects; transportation electrification and electric vehicle infrastructure; electric transmission investments; smart grid investment; energy efficiency; and physical and cyber security.

There is additional opportunity for federal investment in energy and telecommunication infrastructure through the Inflation Reduction Act, just signed into law last week. This will include another almost \$370 billion toward energy security and climate change. I encourage utilities and stakeholders to begin investigating the opportunities and synergies enabled by this new legislation alongside the IIJA.

One of the near-term opportunities I would like to highlight in the IIJA funding is a formula grant to states and Indian Tribes under section 40101(d) for preventing outages and enhancing the resilience of the electric grid. There will be a public hearing taking place to provide more information on the State's approach and gather input on this grant on September 19 at 3pm. You can register for the online public information meeting on EGLE's website. I look forward to seeing what grid reliability and resilience projects this funding will enable."
