Chair Scripps noted:

"In light of the timing of the Commission Meeting dates, the Commission issued an initial Metro tax credit minute action today. We intend to issue another amended minute action at a future Commission Meeting to accommodate those providers that have not yet completed their tax credit applications. For those providers that have not yet submitted the applications, a reminder that the deadline for those providers to submit those requests is no later than May 31st. We will take that up in the June meeting."

A. COMMUNICATIONS

 U-21337 IN THE MATTER TO CONSIDER IMPLEMENTATION OF A RELIEF PLAN FOR THE 313 NUMBERING PLAN AREA (final order)
U-12880 IN THE MATTER, ON THE COMMISSION'S OWN MOTION, TO CONSIDER IMPLEMENTATION OF A 313 AREA CODE RELIEF PLAN

> Case Nos. U-21337 and U-12880 involve applications filed by the North American Numbering Plan Administrator for relief for the 313 area code which is approaching number exhaust. The order before you approves the applications. Commissioner Peretick moved that the Commission approve the order at its May 18, 2023 meeting. Chair Scripps seconded that motion.

Commissioner Peretick commented:

"This is the final order approving the 679 overlay for Detroit's area code. This means that now, a new phone number within Detroit, Hamtramck, Highland Park, Dearborn and Dearborn Heights, Ecorse, the Grosse Pointes, Inkster, Lincoln Park, Redford Township, River Rouge, and Taylor could be assigned either a 313 area code or a 679 area code. This is for newly assigned numbers only and does not result in any changes to existing numbers. Big thanks to our telecommunications team here at the MPSC for your work on this change."

B. ELECTRIC

1. U-17377 IN THE MATTER, ON THE COMMISSION'S OWN MOTION, TO IMPLEMENT THE PROVISIONS OF 2013 PA 95 (notice regarding low-income energy assistance fund/interim order)

> Case No. U-17377 involves implementation of the provisions of Public Act 95 of 2013. The order before you reminds electric utilities of the need to file required Low-Income Energy Assistance Fund information no later than 5:00 p.m. (Eastern time) on June 30, 2023. Commissioner Peretick moved that the Commission approve the order at its May 18, 2023 meeting. Chair Scripps seconded that motion.

Chair Scripps commented:

"This is the first of three orders that we issue in this. This is simply the reminder to file the information in terms of whether or not utilities will opt out of the program. That needs to be received, along with some information on customer accounts. That needs to be received, as Ms. Bachman noted, by June 30th. This is just a critically important program. In 2022, under the program, we and our partners at DHHS, and the grantee organizations, provided energy assistance and self-sufficiency services to more than 56,000 qualifying Michigan households (every corner of the state). Folks who are needing assistance because of challenging economic circumstances received assistance.

Under the law, non-participating utilities are not allowed to shut off service to any residential customer from November 1st to April 15th for non-payment of a delinquent account. It is important for utilities to participate even if they already have policies against shutoffs in place to ensure that their customers have access to this important energy assistance because state law also requires that the funds need to be returned to the regions of state from which they were collected, to the extent possible. The best way to ensure that your customers are able to receive these funds is to participate in the program. I certainly encourage all utilities to do so."

2. U-18238 IN THE MATTER, ON THE COMMISSION'S OWN MOTION, TO REVISE THE STANDARD RATE APPLICATION FILING FORMS AND INSTRUCTIONS PREVIOUSLY ADOPTED IN CASE NO. U-15895 (filing requirements/final order)

> Case No. U-18238 involves a matter, on the Commission's own motion, to consider whether to re-open and revise the Commission's Rate Case Filing Requirements for electric, natural gas, and steam utilities. The order before you approves new Rate Case Filing Requirements; provides a one-year waiver from certain requirements; adopts a process for the approval of a shared protective order; directs the Commission Staff to hold a collaborative on discovery and evidentiary issues specific to rate cases; and directs that the Commission Staff's Case Coordinator shall be included in the service list for all pending and future rate cases. Commissioner Peretick moved that the Commission approve the order at its May 18, 2023 meeting. Chair Scripps seconded that motion.

Chair Scripps commented:

"I appreciate the staff's engagement and the work of the utilities in providing their comments, the attorney general for hers, as well as others who have been involved in this. The statutory deadline for completing rate cases is within 10 months of the date of the filing. It continues to be an onerous requirement and ever more so as those cases grow in length and complexity. I think getting more of the traditional information that is sought in discovery up front (in terms of the filing), having a process for accelerating the process for a protective order, including a shared protective order in many instances, and then working on some of the discovery and evidentiary issues that Ms. Bachman noted, can only accelerate the pace of these and get more of the information included in a sort of somewhat more direct way. My hope is that is alleviates of the burdens, both for our staff and the other participants in these rate cases and provides just a little bit of relief as we go forward."

The order before you sets a deadline for comments and reply comments to be filed on the Commission Staff's March 16, 2023 second interim report recommendations, as described in this order. Commissioner Peretick moved that the Commission approve the order at its May 18, 2023 meeting. Chair Scripps seconded that motion.

4. U-21117 IN THE MATTER, ON THE COMMISSION'S OWN MOTION, TO COMMENCE A STAKEHOLDER PROCESS REGARDING INTERCONNECTION PROCEDURES (interim order)

> Case No. U-21117 involves a matter, on the Commission's own motion, commencing a collaborative addressing the development of electric utility interconnection procedures. The order before you directs electric utilities and member-regulated electric cooperatives to file draft interconnection procedures with the Commission no later than June 16, 2023, directs the Commission Staff to hold a virtual stakeholder workgroup session on June 21, 2023, and directs electric utilities and member-regulated cooperatives to file interconnection procedures pursuant to Mich Admin Code, R 460.920 no later than August 23, 2023. Commissioner Peretick moved that the Commission approve the order at its May 18, 2023 meeting. Chair Scripps seconded that motion.

U-21189 IN THE MATTER OF THE APPLICATION OF INDIANA MICHIGAN POWER COMPANY FOR APPROVAL OF ITS INTEGRATED RESOURCE PLAN PURSUANT TO MCL 460.6t, AVOIDED COSTS AND FOR OTHER RELIEF Case No. U-21189 involves an application requesting *ex parte* approval of Indiana Michigan Power Company's Elkhart County Solar Project Renewable Energy Power Purchase Agreement, Sculpin Solar Project Power Purchase Agreement, Montpelier Capacity Only Purchase Agreement, and Mayapple Solar Project Purchase and Sale Agreement. The order before you denies the *ex parte* application, opens a contested case by setting dates for the prehearing conference and the filing of petitions for intervention, directs Indiana Michigan Power Company to serve this order on all parties to the underlying integrated resource plan proceeding, and instructs Indiana Michigan Power Company to publish the notice of hearing in three newspapers in the company's service territory. Commissioner Peretick moved that the Commission approve the order at its May 18, 2023 meeting. Chair Scripps seconded that motion.

> Case No. U-21310 involves an application filed by Consumers Energy Company and DTE Electric Company seeking *ex parte* approval of cost deferral accounting and a regulatory asset for the costs incurred with restoring allegedly defective work performed by Toshiba America Energy Systems Corporation at the Ludington Pumped Storage Plant. The order before you approves the application as set forth and clarified in the order. Commissioner Peretick moved that the Commission approve the order at its May 18, 2023 meeting. Chair Scripps seconded that motion.

Chair Scripps commented:

"The order before us is an important step in an issue that has been raised in a number of power supply cost recovery and planning cases involving the ongoing litigation with Toshiba to recover costs related to delays and issues relating to some components manufactured and installed at the Ludington Pumped Storage Plant by the contractor. Just to note that the order before us provides Consumers and DTE to create regulatory asset for the costs involved and to utilize deferred accounting, but it does not address the underlying reasonableness of the costs or guarantee cost recovery. Those issues will be addressed in separate proceedings in the future.

In addition, to provide transparency around the total amounts involved, today's order in front of us also directs the utilities to file an annual report in the docket that details the amount of the regulatory asset and then any material developments relating to the ongoing litigation that are likely to impact the total amount of cost exposure, and to work with our staff on the forum and specific elements to be included in this annual report. It is an important step and I appreciate the work that has gone into it to this point."

7. U-21332 IN THE MATTER OF THE APPLICATION OF CONSUMERS ENERGY COMPANY FOR APPROVAL OF A ONE-TIME VOLUNTARY REFUND OF REVENUE (*ex parte*/final order)

> Case No. U-21332 involves a revised proposal filed by Consumers Energy Company requesting approval of a one-time voluntary refund to the company's utility customers and authorization to implement accounting procedures consistent with the refund. The order before you approves the revised proposal. Commissioner Peretick moved that the Commission approve the order at its May 18, 2023 meeting. Chair Scripps seconded that motion.

Chair Scripps commented:

"I really appreciate the proposal brought in from of us today by Consumers Energy. We had some back-and-forth on the appropriate mechanism for this voluntary refund. I think where we land today really does align with the appropriate use of these funds - additional assistance for low-income Michiganders who are struggling, as well as increased tree trimming to address some of the chronic reliability issues that we face in terms of our distribution system. Again, I really do appreciate the back and forth, the concerns raised by others as part of this, and ultimately getting to a position that we are comfortable and indeed enthusiastic about approving."

Commissioner Peretick commented:

"I want to note the significance of this 35-year special contract between DTE and Stellantis for up to 400 MW of solar, so the automaker can meet their goal of reaching 100% clean energy. This is among the largest renewable energy purchases from a utility in the country, following a similar contract between DTE and Ford just 5 months ago, which was at the time the largest-ever renewable energy purchase from an American utility, at 675 MW of solar."

"I would like to note that we are hosting a Resilience Technical Conference next week. This is a two-part technical conference, hosted from 1-5:00 p.m. on Monday, May 22nd and 9-1:00 p.m. Friday, May 26th. This will be a technical conference hosted virtually to discuss options available to us in Michigan for improving the state of our electric reliability. All are welcome to listen. Information on that can be found on the Commission's website.

I want to thank all the fantastic employees that we have here at the MPSC. We had our employee recognition ceremony earlier this morning, and I am always amazed by the dedication and talent of the wonderful employees we have here at the Michigan Public Service Commission. In addition to those employees that will be noted by Chair Scripps in a minute, I want to thank all of the rest of our fantastic employees, as well. Even if you were not called out by name today, you are the reason that Michiganders have safe, reliable, and accessible energy and telecommunication services at reasonable rates. Thank you."

Chair Scripps announced:

"We were able to celebrate a lot of our employees, including those who reached service milestones with the state, as well. Some received special recognition. I want to acknowledge and add them to the record in this meeting, in terms of those folks that we celebrated earlier today.
