Chair Scripps commented:

"I would like to express my appreciation to the 29 electric utilities that indicated that they will be participating in the LIEAF program for the 2023-2024 fiscal year. Those 29 electric utilities represent record participation. We have never had more than 28 before. I am pleased to see this continue to move towards greater participation. In particular, I would like to express my thanks to the Lansing Board of Water and Light, which is participating for the first time. This brings us to 29. As Michigan's largest municipally owned electric utility and one of the five largest electric utilities in the state, the Lansing Board of Water and Light is a leader in many respects, including in reliability and clean energy. I am pleased to see their leadership in this area as well.

The Michigan Energy Assurance Program (MEAP) that is funded by the low-income energy assistance fund plays a critical role in the fabric of assistance programs available to those struggling financially. Last year MEAP provided energy assistance and self-sufficiency services to more than 56,000 qualifying households across the state. We appreciate our network of grantees that work with individuals and families seeking assistance, our partnership in administering this program, the Department of Health and Human Services, and the utilities that participate in the program.

Finally, I want to specifically thank Wanda Clavon-Jones and her team in the MEAP Section of the Commission for their diligent work."

Commission Staff Kayla Gibbs, Commissioner Advisor, presented a brief synopsis of the case listed above. Commissioner Peretick moved that the Commission approve the order at its July 7, 2023 meeting. Chair Scripps seconded that motion.

Commissioner Peretick commented:

"I want to thank everyone who participated in the research and writing of the report just described by Ms. Gibbs, including NREL and all the parties that submitted comments to improve the report and recommendations. This was a huge effort, initially begun and primarily shepherded by former Commissioner Tremaine Phillips, and resulted in an important document that lays out recommendations and next steps to address impacts of increased electricity demand and distributed energy resources. In particular, I would like to thank Kayla Gibbs, Joy Wang, Cody Matthews, Erik Hanser, Nick Evans, Al Freeman, Anna Schiller, Josh Towslee, Jesse Harlow, Cathy Cole, Paul Proudfoot, and Julie Baldwin, and all other staff members who contributed to the report.

As growth in demand for electricity increases due to adoption of electric vehicles and other electrification, and as increased distributed energy resources come online in our state, we need to ensure that we are prepared to handle these changes. The recommendations, as described by Ms. Gibbs, will increase benefits to customers, improve system reliability, ease the interconnection process, allow for growth of DERs, and ensure that the correct changes in grid design and operation are being made to prepare for the future."

Case No. U-21414 involves a request for a declaratory ruling filed by nine member-regulated cooperatives. Commissioner Peretick moved that the Commission approve the order at its July 7, 2023 meeting. Chair Scripps seconded that motion.

Chair Scripps commented:

"I would like to express my thanks to the nine member-regulated cooperatives for bringing this to us. We take steps to stay in our lane to regulate the utilities that we regulate, but not to regulate those that we do not. This was an important clarification that I think reflects the intent of the legislature and certainly our intent in moving forward but provides clarity all around in terms of the applicability of some of the recent rule updates to these member-regulated cooperatives.

Again, I would like to express my appreciation to the nine cooperative electric utilities that brought this to us."

Case No. U-21458 involves an investigation into Consumers Energy Company's meter malfunctions, estimated billing practices, and delay in new service issues. The order before you opens the investigation and directs Consumers Energy Company to file a report by August 4, 2023, and the Commission Staff to submit its analysis of the company's report and recommendations by September 29, 2023. Commissioner Peretick moved that the Commission approve the order at its July 7, 2023 meeting. Chair Scripps seconded that motion.

V. PUBLIC COMMENTS

There were no public comments.

Chair Scripps announced:

"First, I am excited to welcome the appointment of Alessandra Carreon who was appointed by Governor Whitmer last Friday. She will start on the 24th of this month and serve the remainder of former Commissioner Tremaine Phillips' term until July 2025. As noted in Governor Whitmer's announcement, Ms. Carreon joins the Commission from her current role as Manager in the Carbon-Free Transportation program at RMI. Prior to RMI, she managed the Responsible Material Sourcing team at Ford Motor Company and also worked with Ford's Global Sustainability team on ESG and corporate sustainability programs. In addition to these "day jobs", she is also the co-founder and co-owner of PizzaPlexLC3, a Triple Bottom Line business in Detroit that serves authentic Neapolitan pizza. We are excited to welcome her for many reasons. She is engineer. She earned a Bachelor Science degree in Chemical Engineering (with a focus on Environmental Engineering) from Rice University and a Master of Business Administration from the University of Michigan-Stephen M. Ross School of Business. I know that this is the chagrin of many of our employees that you have an entirely U of M Commission at this point. Again, her first day will be July 24th. She will be the first Asian-American member of the Commission. We are excited to welcome Alessandra Carreon in the next couple of weeks.

I want to express my thanks to the Legislature. They recently wrapped up the budget, including ours. It is always a nice chance to say thank you. Notably, relating to the Commission, we received authorization for additional employees related to gas safety activities under authorization delegated by the U.S. Department of Transportation. We received \$21.3 million for renewable energy and electrification infrastructure enhancement and development grants program that received some additional guidance in terms of eligible criteria. I look forward to putting that program together and making some funds available, \$5.5 million to support the activities of Michigan Saves. I would notice in part that Michigan Saves this summer is celebrating \$500 million in loans that have been made under the program since they were created by the Commission in 2008 or 2009. Congratulations to them. There was also direction from the Legislature for the Commission to continue our outreach and public engagement activities we have worked hard over that last couple

of years to step up our activities in that area. I am excited by the Legislature's encouragement and direction for us to continue."

Commissioner Peretick announced:

"The Commission is hosting a virtual energy storage technical conference on July 25th from 1-5:00 p.m. There is additional information is on our website, and the agenda will be posted to the docket for Case No. U-21399 early next week.

Yesterday, the Department of Energy Grid Deployment Office announced the award of \$14.9 million for Michigan's Grid Resilience State Grant. This is supported by the Bipartisan Infrastructure Law, Section 40101(D), these two-year grants will help modernize the electric grid to reduce the impacts of climate-driven extreme weather and natural disasters while ensuring power sector reliability. We look forward to continued collaboration with the Dept of Environment Great Lakes and Energy on the planning and execution of these dollars as subgrants to eligible entities. More information including Michigan's objectives and criteria for subgranting may be found on EGLE's Funding Opportunities webpage titled, "Grid Resiliency".

Chair Scripps announced:

"The annual meeting of the Mid-America Regulatory Conference (MARC) is taking place in Grand Rapids on August 6th – August 9th. We are excited to host that conference. A ton of staff work has gone into it, going back all the way to 2020 when we were originally supposed to hold it. Obviously, it postponed because of the pandemic. A special thanks to Amy Rittenhouse and Sarah Mullkoff for their leadership in putting this together, but it has been the work of many hands. I note that we will have more than 100 speakers, 22 or 23 different sessions (plenary sessions, main stage keynotes, or breakouts) covering a full range of topics from water to energy (electricity and natural gas), telecommunications, and transportation. You name it. If it is a regulated industry, we are covering it. There are also eight workshops and tours. They really highlight all that we have to showcase in Grand Rapids, and indeed Pure Michigan. We are excited for that and are looking forward to welcoming our regulators from across the Midwest to Grand Rapids next month."
