Commission Staff Cody Matthews, Energy Operations Division, presented a brief synopsis of the three cases listed above. Commissioner Peretick moved that the Commission

approve the order in Case No. U-21543 at its July 23, 2024 meeting. Commissioner Carreon seconded that motion.

Commissioner Peretick commented:

"I first want to thank the fantastic staff here at the MPSC who have been working on these interconnection and distributed generation issues for the past few years. It's been a lot of work to revise these rules and then adjust to meet the changes made by the new clean energy laws passed by the legislature and signed by Governor Whitmer last year.

These new laws now require an allowance for 10x the previous capacity of distributed solar generation in our state and made other modifications to make installing rooftop solar panels easier and cheaper for homeowners.

As described by Mr. Matthews, the orders before us right now provide guidance to utilities and customers for how to connect distributed energy generation and storage, directs new DG tariffs to be filed to be consistent with the new energy laws, and approves standard interconnection agreements for projects up to 550 kW to simplify and streamline the process.

I'm excited about the progress we are making in the State of Michigan in expanding distributed solar generation and home energy storage solutions: we now have almost 20,000 customers in MI with distributed solar on their properties, increasing by over 8% year over year according to our Status of Renewable Energy, Distributed Generation, and Legacy Net Metering report for 2023. I'm thankful for our staff, like Mr. Matthews and the whole team he worked with, who have been able to effectively implement these changing parameters from the legislature, changing planning and implementation from utilities, and changing preferences from customers."

7. U-21488 IN THE MATTER OF THE APPLICATION OF ALPENA POWER COMPANY FOR AUTHORITY TO INCREASE ITS RATES FOR THE SALE OF ELECTRICITY (proposed settlement agreement)

Case No. U-21488 involves an application filed by Alpena Power Company for authority to increase its rates for the sale of electricity. The order before you approves an amended settlement agreement resolving all issues in the case. According to key provisions of the amended settlement agreement, the company's tariffs shall be revised to reflect an annual revenue increase of approximately \$2.5 million, effective for service on and after the date of this order. The authorized rate of return on common equity is 9.85%, and the overall rate of return is 6.29%. The amended settlement agreement also includes a subsequent rate increase moratorium with no new general rate increase prior to January 1, 2026. Commissioner Peretick moved that the Commission approve the order at its July 23, 2024 meeting. Commissioner Carreon seconded that motion.

Chair Scripps commented:

"In addition to the core elements that Ms. Day provided, the settlement agreement was agreed to by the Company, our Commission staff, and the Attorney General, also includes a number of additional provisions, including modifying the company's distributed generation tariff to be consistent with the provisions of Public Act 25 of 2023 extending the company's electric vehicle charging pilot through the end of 2028 and revising the time of use provisions and the on peak to off peak ratios in a series of tariffs, including the company's efficient electric heat tariff, a pair of electric vehicle charging tariffs, and tariffs for large power and large industrial customers.

I want to express my thanks to the company, the staff, and the Attorney General for working together on what I think is a constructive settlement in this case. I am pleased to see the order in front of us."

Commissioner Peretick moved that the Commission approve the order at its July 23, 2024 meeting. Commissioner Carreon seconded that motion.

Commissioner Carreon commented:

"I only have a couple of comments I'd like to make, Chair, as Mr. Witt already did an excellent job summarizing the highlights of this order.

First, I want to thank all the interveners in this case, including our MPSC Staff, the Attorney General, and the numerous organizations who contributed their expertise and collaborated towards the resolutions presented in the settlement agreement.

Second, I'd like to underscore the importance of a few developments resulting from this settlement that are designed to engage interested parties and strengthen data availability while providing transparency into Consumers' decision-making approaches. These developments include the agreement for Consumers to undertake the two studies Mr. Witt referenced; the first study examining the breakeven points and bringing the breakeven points and customer charges closer to cost of service and, the second study to provide a more detailed analysis of FERC Account 378. Another development is the requirement to hold an annual technical conference, starting in January 2025, 'for interested parties that will provide the engineering basis and support for the plastic and steel pipe projects selected in the Enhanced Infrastructure Replacement Program planning report,' including "any other decision criteria used by the Company to determine the plan for that calendar year." I would encourage those interested in participating and providing input into these studies or the annual conference to engage as able as these are opportunities not only to receive more insight on the Company's performance reports or cost of service, but they also help inform future prioritization of investment in our energy infrastructure. These studies and the conference are all examples of important ways our utilities can keep the public or interested parties involved and informed on the data and technical details of key infrastructure proposals."

Chair Scripps announced:

"The Commission will hold a public hearing in Marquette next Tuesday, July 30th to hear from the public about the study of Upper Peninsula energy issues as directed by the Legislature. All three Commissioners and a number of our staff will be on hand from 6:00-8:00 p.m. at Northern Michigan University, Northern Central Ballroom II, which is located at 1401 Presque Isle Avenue in Marquette. We are looking forward to meeting with and hearing the perspectives of Upper Peninsula residents.

Second, next month on Wednesday, August 28th, we will have a public hearing in Flint from 6:00-8:00 p.m. at the Riverfront Conference Center, on the campus of University of Michigan-Flint, located at One Riverfront Plaza, Flint. This is related to Case No. U-21638 which we opened in May pursuant to the energy reforms adopted by the Legislature last year to consider options to expand opportunities for public engagement in the Commission's decision-making processes and procedures. We look forward to hearing from individuals there as well.

Third, I would like to congratulate Commissioner Peretick who has been named one of 10 Commissioners from across the country and one of two from the Midwest region to the National Association of Regulatory Utility Commissioner's new Federal and State Current Issues Collaborative in partnership with the Federal Energy Regulatory Commission (FERC). The collaborative is designed to provide a venue for federal and state regulators to share perspectives, improve understanding and (where appropriate) identify potential solutions regarding challenges and coordination on matters that affect specific state and federal regulatory jurisdictions with potential topics to include exploring where best to coordinate between state and federal regulators on issues ranging from electric reliability and resource adequacy to natural gas, electric coordination, wholesale and retail markets, new technologies, innovations, and infrastructure. Congratulations on being named to that new collaborative.

Finally, I would like to invite former Commissioner Bob Nelson to come forward, if he is so willing. It is always fun to embarrass our Commissioners Emeritus. Commissioner Nelson was appointed by Governor Engler in May 1999 to the Commission and reappointed in August of that year. He served with distinction as a member of the Public Service Commission representing independence through July 2, 2005. He has had a rich post-Commission career, including (perhaps most notably) helping to form the Citizens Utility Board of Michigan (CUB) and serving on its Board of Directors until stepping down earlier this year as he pursues retirement full-time. Both at the MPSC and CUB, Commissioner Nelson has been universally regarded for his thoughtfulness, his kindness, his regulatory expertise, and his passion for the interests of utility customers.

What folks may not know is that he is also well known internally as the informal Bard of the Commission, helping to initiate a tradition of Commissioner karaoke, where we take popular songs and rewrite them with energy and telecommunications themes. Yes, we really are that nerdy here! That has led to such favorites as The Eagles' 'Take it Easy' being repurposed by former Commissioner Norm Saari as 'Take an EV', George Strait's classic 'Amarillo by Morning' to bid former Chair Sally Talberg goodbye with 'ERCOT Board by Morning' and with great offense to Prince, redoing 'Purple Rain' as 'PURPA Rain'. It is a tradition that carries on to this day and started by Commissioner Nelson.

As you prepare to step into retirement, I want to congratulate you on your many contributions, both in the orders and work of the Commission, and perhaps even more importantly to the culture of the Commission and to CUB and organizations that you have been a part of. While you were 'All about those rates – those rates and tariffs' to perhaps paraphrase Megan Trainer's classic, as a Commissioner you showed us that according to the Beatles 'All you Need is Love' or perhaps 'All you Need is CUB' in your retirement years and maybe to start with the opening lines of *There's Nothing you can do Bob hasn't done/He taught us all to sing/And then we sung*. Perhaps that is the greatest tribute of all.

Congratulations and good luck in your next chapter."

Bob Nelson thanked the Commission and indicated that he appreciated the recognition.
