"I want to note that these capacity demonstrations and the work in evaluating the capacity demonstrations are an important element of the resource adequacy framework that we have here at the Commission. The capacity demonstration process was established under the 2016 energy laws and provides additional transparency and visibility into some of the changes that are taking place in the electric sector that help us to responsibly manage the ongoing energy transition.

The report from the staff (after considering the resource adequacy demonstrations by load serving entities and alternative electric suppliers) finds that we have adequate generation supplies to meet expected customer needs in the capacity demonstration timeline. I appreciate the work of the companies in filing these demonstrations and the work of the staff in reviewing them. It is, again, an important piece of the framework that we have to ensure that we are able to maintain reliability going forward."

Angelita Gonzales, Detroit, commented about the DTE 2024 rate hikes.

Heidi Drumheller commented on Case No. U-21472. She provided an update on the case and indicated that MLive is doing a story on the marsh located near her home regarding the EMR habitat and the eastern massasauga rattlesnake, which is protected.

Chair Scripps announced:

"We have a number of positions posted on our website: www.michigan.gov/mpsc where we are hiring. I believe that we have six open positions at this point. We have a number of public utility engineers, analysts in a number of different sections (Gas Operations), some related to the new siting law. I encourage any who are interested to check that out and apply if you are interested. We would love to add you to the team as we grow out to meet the responsibilities asked of us by the Legislature in last year's energy legislation.

Earlier today, the draft Sound Report Guidelines-Appendix I was filed to the docket in the siting case, which is U-21547. The purpose of the Sound Report is to provide the Commission with information necessary to access whether the facility meets the noise limits defined in the energy

laws enacted last year. We are in the process (it is noted in the docket as well) of seeking comment of the draft report on sound modeling guidance. Staff intends to hold a public meeting to review the modeling guidance on Wednesday, September 4th at 3:00 p.m. Comments on the draft sound modeling guidance are requested to the docket by September 11th. Those are a couple of dates for the calendar as we continue the implementation of the new energy laws, particularly the elements around siting of renewable energy generation projects.

Finally, I want to congratulate Commissioner Peretick on being named Vice Chair of the Advisory Committee to the Electric Power Research Institute. We have gotten a lot out of our engagement with EPRI, particularly your participation and leadership in that organization. I am glad to see that reflected in a formal leadership role going forward."
