On November 30, 2023, Atos Public Safety, LLC filed an application with the Michigan Public Service Commission (MPSC), as amended on April 1, 2024, June 21, 2024 and further supplemented on July 18, 2024; for both a temporary and permanent license to provide basic local exchange service in all zones and exchange areas in the State of Michigan. Atos Public Safety, LLC, shall publish a notice of hearing in accordance with 1991 PA 179, as amended and the Michigan Office of Administrative Hearings and Rules System's Administrative Hearing Rules, Rules of Practice and Procedure Before the Commission, no later than August 6, 2024. A copy of the notice of hearing and proofs of publication shall be filed with the Commission no later than August 14, 2024.
