Staff testimony, if any, shall be filed with the Commission on or before November 22, 2024. Rebuttal testimony shall be filed with the Commission on or before December 2, 2024. Interventions are due on or before December 6, 2024.

Stratus Networks, Inc., shall publish a notice of hearing in accordance with 1991 PA 179, as amended. A copy of the notice of hearing and proofs of publication shall be filed with the Commission by the hearing on December 13, 2024.
