On April 11, 2025, PB Michigan Fiber Asset Entity, LLC filed an application, later amended on May 30, 2025, with the Michigan Public Service Commission (MPSC), for a temporary and, ultimately, a permanent license to provide basic local exchange service in the incumbent local exchange carriers' service territories throughout the State of Michigan. This matter is set for an evidentiary hearing at **9:00 AM on Friday, July 18, 2025 before the Michigan Public Service Commission, to be held by Video/Teleconference before Administrative Law Judge Christopher S. Saunders.**

Requests for adjournment must be made pursuant to the Michigan Office of Administrative Hearings and Rules System's Administrative Hearing Rules R 792.10422 and R 792.10432. Requests for further information on adjournment should be directed to (517) 284-8130.

Staff testimony, if any, shall be filed with the Commission on or before June 27, 2025. Rebuttal testimony shall be filed with the Commission on or before July 4, 2025. Interventions are due on or before July 11, 2025.

PB Michigan Fiber Asset Entity, LLC, shall publish a notice of hearing in accordance with 1991 PA 179, as amended. A copy of the notice of hearing and proofs of publication shall be filed with the Commission by the hearing on July 18, 2025.
