NOTICE OF PUBLIC HEARING

**IN THE MATTER OF THE APPLICATION OF DTE ELECTRIC COMPANY FOR
APPROVAL OF SPECIAL CONTRACTS**

- DTE Electric Co. requests approval of a Primary Supply Agreement and Energy Storage Agreement (the Special Contracts) with Green Chile Ventures, LLC, which plans to lease and operate a data center facility in DTE Electric's service territory, at or near Saline, Michigan.
- This hearing is intended to provide members of the public an opportunity to provide comments regarding DTE's application. The meeting will be legislative in nature, and any person may present data and views during the public comment period.
- Any person may review the application and other documents filed in the case through the Commission's [Electronic Docket](#) system under Case No. [U-21990](#).
- The meeting is open to the public, and the information below describes how a person may participate.

PARTICIPATION: The hearing is open to the public, and any interested person may participate by using the [Teams Link](#) or by dialing 1-248-509-0316 and entering the conference ID 593258092# when prompted.

Persons needing any assistance to participate should contact the Commission's Executive Secretary at (517) 284-8090 in advance of the hearing and are encouraged to do so by November 26, 2025.

A transcript of the public hearing will be filed in the docket for Case No. U-21990. This hearing may also be recorded, and the recording may be posted at www.YouTube.Com/MichiganPublicServiceCommission.

Public Comment for the Public Hearing:

Members of the public who wish to make a comment may do so during the public comment portion of the hearing, subject to the following requirements. Comments should be limited to no longer than three (3) minutes; however, the presiding officer will manage the public comment process and may adjust or place further limits on how long a person may speak.

Public comments must be directed to the Commission and should not be used to engage with other participants or respond to their comments. The public comment period is an opportunity for Commissioners to listen to comments and concerns and not to answer questions. Public comments should be limited to one per person.

Individuals wishing to make a verbal comment through the Microsoft Teams platform should click on the “raise hand” button to be queued up for comment. When it is your turn to speak, please click on the “mic” button to unmute. Individuals participating through Microsoft Teams also have the option to turn on their cameras. Individuals wishing to make a verbal comment through the call in option should press *5 to be queued up for comment. When it is your turn to speak, press *6 to unmute.

Commenters on both Microsoft Teams and on the phone are added to the same speaker queue and will be called upon in the order they enter the speaker queue. Please do not lower your hand or press *5 again after joining the queue or you will be removed from the queue and lose your place in line.

In the event of a disconnection caused by the hearing host, the public hearing will be in recess. Every effort will be made to reestablish a publicly accessible connection. If the host is unable to do so within 15 minutes from the time of the disconnection, the hearing will adjourn. The hearing will not recess or adjourn due to technical or other issues experienced by individual members of the public that render them unable to participate in the hearing. Members of the public who have intermittent internet service should consider listening to the hearing via telephone to avoid missing any part of the hearing.

Members of the public who are speech or hearing impaired may participate in this hearing by dialing 7-1-1 and using the [Michigan Relay service](#). As stated above, persons needing any accommodation to participate may contact the Commission’s Executive Secretary at (517) 284-8090.
