On July 11, 2025, Interactive Services Network, Inc. filed an application with the Michigan Public Service Commission (MPSC), as amended on October 21, 2025, for both a temporary and permanent license to provide local exchange service in all exchanges in the state of Michigan. This matter is set for an evidentiary hearing at **9:00 AM on Thursday, January 15, 2026 before the Michigan Public Service Commission, to be held by Video/Teleconference before Administrative Law Judge James M. Staff testimony, if any, shall be filed with the Commission on or before December 23, 2025. Rebuttal testimony shall be filed with the Commission on or before December 30, 2025. Interventions are due on or before January 8, 2026.

Interactive Services Network, Inc., shall publish a notice of hearing in accordance with 1991 PA 179, as amended. A copy of the notice of hearing and proofs of publication shall be filed with the Commission by the hearing on January 15, 2026.
