Dear Mr. Hanselman:

On February 23, 2021, Thumb Electric Cooperative filed an application with the Michigan Public Service Commission (MPSC), as amended on March 3, 2021, for a license to provide basic local exchange service in designated exchanges as identified in Exhibit A of its amended application. This matter is set for an evidentiary hearing at **9:00 AM on Tuesday, April 27, 2021 at the Michigan Public Service Commission, to be held by Video/Teleconference before Administrative Law Judge Kandra Robbins.**

On March 19, 2021, the Michigan Public Service Commission issued an Order granting Thumb Electric Cooperative of Michigan, d/b/a TEC Fiber, a temporary license to provide basic local exchange service in the designated exchanges listed in Exhibit A of its amended application. The temporary license shall expire upon issuance of the final order granting or denying the application for a permanent license, or a period not to exceed one year, whichever occurs first.

Requests for adjournment must be made pursuant to the Michigan Administrative Hearing System's Administrative Hearing Rules R 792.10422 and R 792.10432. Requests for further information on adjournment should be directed to (517) 284-8130.

Staff testimony, if any, shall be filed with the Commission on or before April 6, 2021. Rebuttal testimony shall be filed with the Commission on or before April 13, 2021. Interventions are due on or before April 20, 2021.

Thumb Electric Cooperative, shall publish a notice of hearing in accordance with 1991 PA 179, as amended. A copy of the notice of hearing and proofs of publication shall be filed with the Commission by the hearing on April 27, 2021.
