#### Public Comment for the Public Hearing:

Members of the public who wish to make a comment may do so during the public comment portion of the hearing, subject to the following requirements. Public comments must be directed to the Commission and should not be used to engage with other participants or respond to their comments. The public comment period is an opportunity for commissioners to listen to comments and concerns and not to answer questions. Public comments should be limited to one per person.
