# Public Comments:

Members of the public who wish to make a comment may do so during the Public Comment portion of the meeting, pursuant to the Commission's bylaws. The public may also submit written comments to the Commission via email at <u>mpsc\_commissioners@michigan.gov</u>.

The Commission will take public comments in the following order: in person and by phone. Public comments must be directed to the Commission and should not be used to engage with other participants or respond to their comments. The Public Comment period is an opportunity for commissioners to listen to comments and concerns and not to answer questions. Public comments are limited to three (3) minutes and one per person.

The public may provide input or ask questions on any business that will come before the Commission at the meeting or via email at <u>mpsc\_commissioners@michigan.gov</u>. Public comments pertaining to a specific case should be submitted to <u>mpscedockets@michigan.gov</u>.

### Public Comment by Remote Participation:

In addition to in-person comments at the Commission meeting, members of the public may make public comments by phone.

After taking any comments from individuals attending in person, the phone line will be opened for those who called into the meeting and would like to address the Commission verbally. If you want to be queued up for verbal comments and have access to the Microsoft Teams Livestream, please enter your name and the county where you live in the Q&A feature and indicate that you wish to make a verbal comment. These names will be called on in the order received. After hearing from those individuals listed in the Q&A feature, the Chair will provide an opportunity for comments from individuals who are on the phone line but not utilizing the online Q&A feature.

For individuals participating by phone and who want to make verbal comments, you may press \*5 to be queued up for comment. Attendees participating by phone will be muted until we reach the time for public comment. When it is your turn to speak, press \*6 on your phone to unmute. Please indicate your name and the county where you live before beginning your public comment.
